Further, I agree, if approved by the Board to become a Full Member, to work a minimum of two (2) full days at one Club hunt test each calendar year and to work a minimum of one (1) additional full day on the grounds outside of a Club hunt test each calendar year. I understand that it is my responsibility to get credit for completion of work days. Members aged 70 years or older are exempt from work requirements. I understand that only Full Members who satisfy club requirements may access club grounds unaccompanied. The non-refundable application fee listed below is inclusive of your first year dues from the period of your acceptance as a Probationary Member into the Club through the end of the calendar year in which you first become a member.
